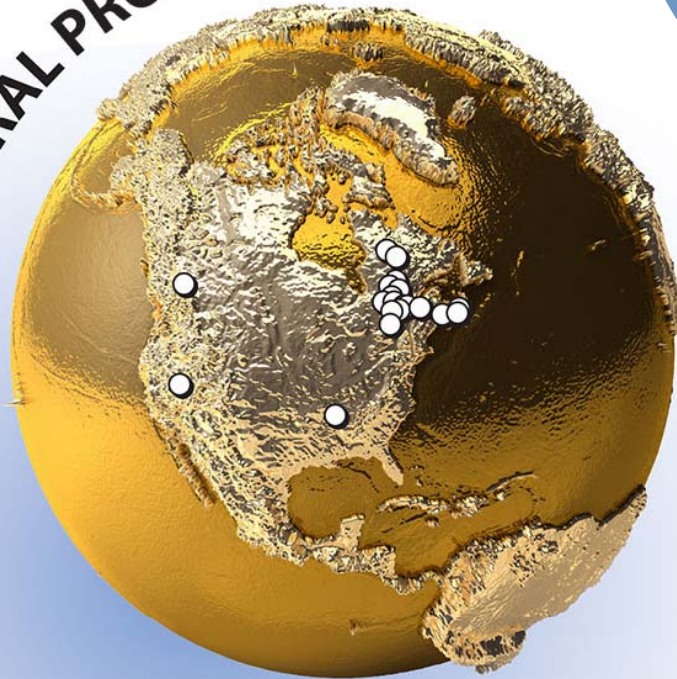

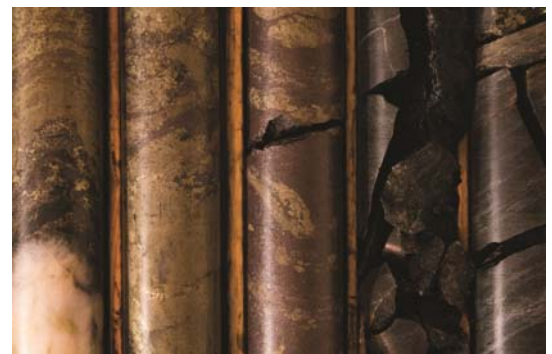
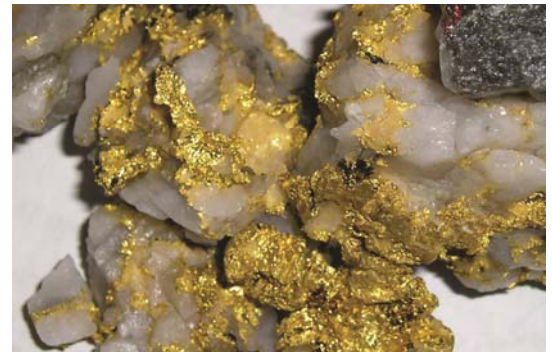
**Advanced Projects**
