

## Renforth Concludes Successful Prospecting Program at Parbec

### New Release Highlights

- Gold bearing magnetic diorite system intersected on surface south of Cadillac Break
- Historically mapped diorite body proven gold bearing
- Mineralized historic trenches re-discovered in extreme NW of property
- Additional gold-bearing sample obtained in “Island Trenches” discovery area

**Renforth Resources Inc. (CSE – RFR)** (“Renforth” or the “Company”) is pleased to share results obtained during our recent surface prospecting program at Parbec, where we met our main objective in the program, locating the historically mapped diorite body and determining it to be a gold bearing magnetic diorite. Historic trenches in the NW of the property were also re-discovered during a prospecting traverse, the porphyry within these returned gold grades. These trenches are located on strike ~370m from the western edge of the 2016 Parbec Resource and ~190m from the westernmost hole in the recent drilling, PAR-18-80. The Island trenches were revisited and sampled, returning gold. Samples obtained in each location demonstrate the presence of mineralized gold systems.
